 - Receive the February 2010 Financial Report and file for Audit A. MOTION: Donald Padlo moved to accept and file the February 2010 Financial Report for audit; seconded by Peter McBrien; passed unanimously.
 - Approve March 4, 2010, Regular meeting minutes MOTION: Stephen Mindera moved to approve the March 4, 2010 meeting minutes as presented; seconded by Craig Diangelo; passed unanimously.
 - Standing Committee Reports C.
 - Program, Finance, and Personnel (PFP) Committee Chair, Stephen Mindera reported that PFP discussed the availability of staff time funded by the General Fund for zoning/planning referrals and how that was affected by loss of the State-Grant-in-Aid funds. There was some discussion of that subject by the Board and staff indicated that they would continue to monitor the situation and report back to the Board. Chairman Mindera also reported on action the PFP took to recommend a change in Personnel Policy regarding employees who do not participate in the health insurance program, and advised that the Board would be asked to take action on that policy when the FY2010-2011 budget was presented for adoption.

 - Resolution 20100401A STIP/TIP Amendment on Project a. 0170-2776, Surface Transportation Program Funds for Engineering/Scoping and Project Development - Statewide -Regional Planner Michael Tonelli reported after some clarification that this Resolution does not need to be executed.

It was suggested that these letters be reviewed by the Chair of the Agency Board, or, possibly, by an Executive Committee, in the future prior to finalizing them to assure that they do not conflict with Agency Policy. Staff offered to bring back suggestions for addressing that situation at a future Board meeting.
