 Ms. Nusom Haverstock presented information on Light Impact Development and distributed CDs with information about LIDs for use by the towns.

 MOTION: Donald Naples moved to accept the May, June and July 2010 Financial Reports and file for Audit; seconded by Peter McBrien; passed unanimously

 MOTION: Donald Naples moved to accept the June 3, and August 13, 2010 meeting minutes as presented; seconded by Rudy Cabata; passed, Jennifer Bartiss-Earley abstaining, and John Pompei opposed
- C. Standing Committee Reports
1. Program, Finance, and Personnel (PFP) Committee/Pension Plan Trustees,
- a. Revisions to the Pension Plan Adoption Agreement, effective July 1, 2009
 MOTION: Stephen Mindera moved to accept the revised Pension Plan Adoption Agreement, effective July 1, 2009, reflecting changes required by Federal law, and to reflect the new membership of the Pension Plan Trustee Board; seconded by Steven Schiller; passed unanimously.
- b. FY2011-2012 Member Municipality Dues
 MOTION: Donald Naples moved to approve the municipal dues amounts and allocation formula for FY 2011-2012; seconded by Steven Schiller; passed unanimously.
- c. Personnel Policy Amendment and Related Budget Revisions for the Regional Planner Position
 MOTION: Stephen Mindera moved to approve the amendment to the Personnel Policy of adding the Regional Planner Classification Description along with setting a salary of \$42,000 annually, and to increase the annual salary of the Transportation Planner by \$3,000 to match the salary of the Regional Planner; seconded by Peter McBrien; passed unanimously.

 MOTION: Stephen Mindera moved to approve the staff proposed amendments to the FY2010-2011 Budget noting adjustments of two line

items; \$119,559 to the Health/Life Insurance/STD and \$33,100 Equipment/Software Purchases (these amounts needed to be adjusted at the time of the PFP meeting upon discovery of an adding error) seconded by Donald Padlo; passed unanimously.
